

First Mile Privacy Policy

First Mile 隱私權政策

It is First Mile (hereinafter, referred to as the “**FM**”) policy to respect your privacy regarding any personal data we may collect while operating our services on FM, available at firstmile.fusions360.com and the accompanying mobile application FM. Accordingly, we have developed this privacy policy (hereinafter, referred to as the “**Privacy Policy**”) in order for you to understand how we collect and process (i.e., use, store, share, disclose and otherwise make use of) your personal data. This Privacy Policy will also cover your rights in relation to your personal data.

First Mile (下稱「**FM**」) 政策之目的在於當本公司在 firstmile.fusions360.com 及相關行動應用程式上使用 FM 服務時，因可能蒐集任何個人資料，為尊重您的隱私權。因此，本公司制定本隱私政策（下稱「**本隱私權政策**」），以便您瞭解本公司如何蒐集與處理（即使用，儲存、分享、揭露及以其他方式利用）您的個人資料。本隱私權政策亦涵蓋您對於您的個人資料所享有的相關權利。

IF YOU REGISTER WITH OR ACCESS FM SERVICES OR THIS SITE, YOU ARE DEEMED TO AGREE TO THE TERMS AND CONDITIONS OF THIS PRIVACY POLICY. YOUR NON-TERMINATION OR CONTINUED ACCESS TO OR USE OF ANY FM SERVICES OR THIS SITE AFTER THE EFFECTIVE DATE OF ANY AMENDMENTS, CHANGES, OR UPDATES CONSTITUTES YOUR ACCEPTANCE OF THIS PRIVACY POLICY, AS MODIFIED BY SUCH AMENDMENTS, CHANGES, OR UPDATES. IF YOU DO NOT UNDERSTAND THE PRIVACY POLICY OR DO NOT AGREE TO ONE OR MORE PROVISIONS OF THIS PRIVACY POLICY, PLEASE IMMEDIATELY CEASE YOUR USE OF FM.

This Privacy Policy does not cover any personal data that we may receive about you through sources other than FM.

本隱私權政策不包括本公司可能透過 FM 服務以外的其他來源所收到的任何個人資料。

This Agreement specifically incorporates by reference the entirety of our TERMS OF USE and DISCLAIMER.

1. INFORMATION COLLECTION

1. 資訊蒐集

1.1 Through your use of FM, you will be subject to different types of personal data collected and different manners of collection. We will collect and process your personal data in a lawful, fair, and transparent manner and, where appropriate, with your knowledge or prior explicit consent. Personal data will be relevant to the

purposes for which they are to be used, and, to the extent necessary for those purposes, should be accurate, complete, and up-to-date.

1.1 透過您使用 FM 服務，本公司將會以不同方式蒐集您不同類型的個人資料。本公司將會以合法、公平及透明之方式，在適當情況下，在您明知或先經您的明確同意而蒐集與處理您的個人資料。個人資料將會與其使用之目的相關、限於所需目的範圍內，並應保持正確完整且最新之狀態。

1.2 FM may collect the categories of information, including, but not limited to, the categories described as below:

1.2 FM 得蒐集的資訊類別，包括但不限於下列類別：

(a) REGISTRATION: You, as a user of FM , may be asked to register an account to use FM or access any of the services thereon. During the process of your registration, you will be asked to provide your email address, a password, your Ethereum signature (if you opt for registration through Ethereum) and any cryptocurrency wallets that you would like to disclose. We use these personal data to provide the services to you and ensure the security of FM.

(a) 註冊：作為 FM 的用戶，您可能被要求註冊帳戶以使用 FM 或進入任何服務。在您註冊過程中，您將被要求提供您的電子郵件地址、密碼、您的以太坊簽名(如果您選擇使用以太坊註冊)以及您想要揭露的任何加密貨幣錢包。我們使用這些個人資料為您提供服務並確保 FM 的安全性。

(b) BILLING: If you elect to use any of our paid services, you will be asked to provide billing information, such as, but not limited to billing address. This personal data will be used specifically for providing you with the services you have purchased. The payment and billing information may be stored for the time period as required by applicable law for lawful purposes (e.g., accountancy records).

(b) 結算：如果您選擇使用本公司的任何付費服務，則系統會要求您提供付費資訊，例如但不限於帳單地址。此個人資料將專門用於為您提供所購買的服務。付款與帳單資訊得依據相關法律規定儲存一段時間以符合法定目的（例如，會計紀錄）。

(c) CRYPTO AND FINANCIAL INFORMATION: Depending on how you choose to interact with the FM services, you may be asked to provide your cryptocurrency wallet and general portfolio information and other information that will assist us in providing the services to you. You may also be asked for application programming interface(API) access for certain accounts which may be aggregated for you on FM.

(c) 加密貨幣 (CRYPTO) 與財務資訊：根據您選擇與 FM 服務互動之方式，可能會要求您提供加密貨幣錢包與一般個人簡介資料及其他有助於本公司提供服務給您的資訊。本公司亦可能要求您對特定帳戶接入應用程式介面 (API)，而可為您在 FM 服務上進行整合。

- (d) USE: Through your use of FM, you may be asked questions about how to improve FM or you may, at some point, communicate with representatives of FM. We will receive your email address, as well as the contents of your communications, answers to questions and any other form of contact between you and FM. We will use personal data contained in such communications only for the purposes of providing you with the requested information and for improving the services.
- (e) 使用：透過使用 FM 服務，本公司可能詢問您如何改善 FM 服務的問題，或您可能就某些觀點與 FM 服務的代表溝通。本公司將會接收您的電子郵件信箱、您的通訊內容、對問題的回答及您與 FM 之間的任何其他聯絡方式。本公司將僅基於提供所需資訊給您及改善服務之目的而使用上述通訊中所含的個人資料。
- (f) AUTOMATIC COLLECTION: We may collect information from you through automatic tracking systems on your device or through the FM application programming interface, or API, or other web and mobile analysis software. We may also receive certain usage data, such as your IP address and referral source. We use this information for our legitimate business interests, including analyzing usage of FM.
- (e) 自動蒐集：本公司可能透過您設備上的自動追蹤系統或透過 FM 服務應用程式介面或 API，或其他網路與行動分析軟體向您蒐集資訊。本公司亦可能會接收特定使用資料，例如您的 IP 地址及推薦來源。本公司將基於合法商業利益使用此資訊，包括分析 FM 服務的使用情況。
- (g) COMBINED OR AGGREGATED INFORMATION: We may combine or aggregate some of your personal data in order to better serve you and to better enhance and update FM for your and other users' use.
- (f) 組合或整合資訊：本公司可能會合併或彙整您的一些個人資料，以便提供更佳的服務給您，並對於您與其他使用者的使用提供更加強化功能及更新 FM 服務。
- (h) NON-PERSONAL DATA: We may collect non-personal data, such as browser types, operating systems, and the URL addresses of websites clicked to and from FM, including referral links we may post on FM in order to analyze what kind of users visit FM, how they find it, how long they stay, from which other websites they come to FM, what pages they look at, and to which other websites they go from FM. In case your non-personal data are aggregated with certain elements of your personal data in the way that we may become able to identify you, such non-personal data will be treated as personal data.
- (g) 非個人資料：本公司可能會蒐集非個人資料，例如瀏覽器類型、作業系統及點擊進出 FM 網站的網址，包括本公司可能會在 FM 網站上發布的推薦連結，以分析哪種類型使用者會造訪 FM 網站、是如何找到 FM 網站、停留的時間有多久、是從其他哪些網站進到 FM 網站、查看的網頁，以及自 FM 網

站到哪些其他網站。如果您的非個人資料與本公司可能識別您個人資料的特定元素相結合，則此類非個人資料將視為個人資料。

1.3 FM will collect your personal information until (a) FM ceases to provide Services and this Site, or (b) you explicitly request FM to cease to collect your personal information by contacting us through the contact information referred in this Privacy Policy and in accordance with the Article 6 of this Privacy Policy, in which case we may not be able to provide FM Services and this Site to you.

1.3 FM 將蒐集您的個人資料，直到 (a) FM 停止提供本服務及本網站，或 (b) 您明確要求 FM 停止蒐集您的個人資料為止，請透過本隱私權政策所列的聯絡資訊與本公司聯絡。在此情況下，依據本隱私權政策第 6 條規定，本公司可能無法向您提供 FM 及本網站之服務。

1.4 FM will collect and store your personal information when you access or use FM Services and this Site. Your personal information may be exported outside of the jurisdiction in which you reside and will be stored in Taiwan, provided that the location may change from time to time, depending on the services provider used by FM (the “**Data Location**”). Under those circumstance, the governments, courts, law enforcement, or regulatory agencies of the Data Location may be able to obtain access to your personal information through foreign laws. You need to be aware that the privacy standards of the Data Location may be lower than those of the jurisdiction in which you reside.

1.4 當您登入或使用 FM 及本網站之服務時，FM 將會蒐集並儲存您的個人資料。您的個人資料可能會輸出到您居住地的司法管轄區外，並將儲存在台灣，但上述地點可能會不定時變更，將視 FM 使用的服務供應商（「資料儲存地點」）而定。在此情況下，資料儲存地點所在、政府、法院、執法機關或主管機關可能會透過外國法律取得您的個人資料。您需要知道，資料儲存地點的隱私權保護標準可能低於您居住所在地司法管轄區的隱私權保護標準。

2. PROCESS AND USE OF PERSONAL INFORMATION

2.1 FM may process and use your personal information for the purposes, including, but not limited to, the purposes described as below. Please note that one or more purposes may apply simultaneously.

2.1 FM 可能基於包括但不限於下列目的處理及使用您的個人資料。請注意，可能同時適用一個或以上之目的。

(a) Provision of FM Services and this Site. FM may process and use your personal information to authenticate your identity, validate the process that you access or use FM Services and this Site, facilitate your Orders, execute the Trades between you and other users, develop, enhance, and market FM Services, provide FM Services to you, process billing and collect any fees, or as otherwise may be necessary to execute the agreement between you and FM, or to identify you or to ensure the functionality and security of FM Services and this Site.

- (a) 提供 FM 服務和本網站：FM 可以處理及使用您的個人資訊以驗證您的身分、驗證您登入或使用 FM 服務與本網站之程序、加速您的訂單處理、執行您與其他使用者之間的交易、開發、加強及行銷 FM 服務，提供 FM 服務給您、處理帳單及收取任何費用，或其他方面以履行您與 FM 之間的契約，或識別您的身分或確保 FM 服務與本網站之功能及安全。
- (b) Development of FM Services and this Site. FM may process and use your personal information, Content, and/or Feedback to develop, improve, and customize FM Services and this Site. FM may also perform research and analytics on your personal information to personalize our offering, for example, to make recommendations and to display customized content and advertising in our websites.
- (b) 開發 FM 服務和本網站。FM 可能會處理並使用您的個人資訊、內容及／或回饋意見，以開發、改進及客製化 FM 服務與本網站。FM 亦可能對您的個人資訊進行研究與分析，以個性化本公司的產品，例如提出建議並在本公司的網站上顯示客製化的內容及廣告。
- (c) Service-Related Interaction. FM may process and use your personal information, Content, and/or Feedback to communicate with you, for example, to provide information relating to FM Services and this Site. FM may also send service-related email, conduct surveys and get Feedback from you or otherwise interact with you when you register with or access FM Services and this Site based on the information you provide us.
- (c) 服務相關之互動。FM 可能會處理並使用您的個人資訊、內容及／或回饋意見與您溝通，例如，提供 FM 服務與本網站相關的資訊。FM 亦可能根據您提供給本公司的資訊，在您註冊或登入 FM 服務與本網站時傳送服務相關的電子郵件、進行調查並取得您的回饋意見或與您互動。
- (d) Dispose of de-identified personal information. To the extent permitted by applicable laws, FM may dispose the information it collects during the process of providing FM Services to other third party, provided that FM will take de-identification measures (such as removing personal identifiers and removing or altering other information that may allow any person to be identified). However, please note that there is a possibility that another dataset or other information could be matched with the de-identified information. FM does not guarantee that the de-identified information will not be re-identified.
- (d) 去識別化個人資訊處理。在相關法律許可的範圍內，FM 得將其提供 FM 服務過程所蒐集的資訊處置給其他第三方，但 FM 將採取去識別化之措施（例如刪除個人識別碼並刪除或更改其他可能識別任何人的資訊）。然而，請注意，仍可能會有另一資料組或其他資訊與去識別化資訊相匹配。FM 不保證去識別化資訊不會重新具有識別性。

(e) Compliance with laws and regulations. FM may process and use your personal information, Content, and/or Feedback to meet legal and regulatory requirements, including, but not limited to, Anti-Money Laundering and counter-terrorist financing, or as otherwise may be necessary to execute the agreement between you and FM. FM reserves the right to retain and share certain personal information in order to meet our regulatory requirements and further to our contractual agreements with partners and third parties.

(e) 法規遵循事項。FM 可能會處理並使用您的個人資訊、內容及／或回饋意見，以符合法律與法規之規定，包括但不限於洗錢及資助恐怖活動之防制，或其他可能需要的方面以履行您與 FM 之間的契約。FM 保留得保存及分享特定個人資訊之權利，以符合法規對本公司之要求，並進一步遵守與合作夥伴及第三方之間的契約約定。

2.2 FM will process and use your personal information until (a) FM ceases to provide Services and this Site, or (b) you explicitly request FM to cease to process and use your personal information by contacting us through the contact information referred in this Privacy Policy, in which case we may not be able to provide FM Services and this Site to you.

2.2 FM 將會處理和使用您的個人資訊，直到 (a) FM 停止提供本服務及本網站，或 (b) 您明確要求 FM 停止處理及利用您的個人資訊為止，請透過本隱私權政策所列的聯絡資訊與本公司聯絡。在此情況下，本公司可能無法向您提供 FM 及本網站之服務。

2.3 FM will process and use your personal information and other data in the Data Location and it may be outside of the jurisdiction in which you reside. Under those circumstance, the governments, courts, law enforcement, or regulatory agencies of the Data Location may be able to obtain access to your personal information through foreign laws. You need to be aware that the privacy standards of the Data Location may be lower than those of the jurisdiction in which you reside.

2.3 FM 將在資料儲存地點處理及使用您的個人資訊與其他資料，此地點可能位於您居住所在地的司法管轄區外。在此情況下，資料儲存地點所在、政府、法院、執法機關或主管機關可能會透過外國法律取得您的個人資訊。您需要知道，資料儲存地點的隱私權保護標準可能低於您居住所在地司法管轄區的隱私權保護標準。

3. THIRD-PARTYS

3. 第三方

3.1 We may utilize third party service providers, from time to time or all the time, to help us with FM and to help to serve you. Such third-party service providers may include:

- (a) Data storage companies (e.g., cloud storage providers);
- (b) User information logistics providers (e.g., Google Analytics or other analytics companies which help us track general user information and usage);
- (c) Website hosting companies;

- (d) Decentralized platform(e.g., Ethereum or other blockchain-based distributed computing platform)
 - (e) Newsletter providers; and
 - (f) Other parties who assist us in operating FM and conducting our business.
- 3.1 本公司可能會不定時或隨時利用第三方服務供應商以協助本公司經營 FM 服務並提供協助給您。此類第三方服務供應商可能包括：
- (a) 資料儲存公司（例如，雲端儲存供應商）。
 - (b) 使用者資訊運算服務供應商（例如，Google Analytics 或其他協助本公司追蹤一般使用者資訊及使用情況的分析公司）。
 - (c) 網站託管公司；
 - (d) 去中心化平台(如，以太坊或其他基於區塊鏈的分散式計算平台)
 - (e) 電子報提供商; 和
 - (f) 通訊服務供應商協助本公司經營 FM 服務及開展業務的其他人。

3.2 We do not sell, trade, or transfer your personal data to third parties not indicated in this Privacy Policy, unless we obtain your prior explicit consent.

3.2 除經本公司事先明確同意者外，本公司不會將您的個人資料出售、交易或移轉給本隱私權政策中未指明的第三方。

3.3 Please note that some non-personal data may be provided to third parties for marketing, advertising, or other uses. We also allow third-party behavioral tracking which may include non-personal data.

3.3 請注意，某些非個人資料可能會提供給第三人作為行銷、廣告或其他用途。本公司亦容許第三方進行行為追蹤，其中可能包括非個人資料。

3.4 We are not responsible for actions of third parties that are not mentioned in this Privacy Policy and with whom you share your personal data, and we have no authority to manage or control third party solicitations.

3.4 本公司對於本隱私權政策中未提及的第三方及您分享您個人資料的對象之行為，不負任何責任，本公司無權管理或控制第三方之請求。

4. Transmittals

4. 傳輸

4.1 From time to time, we may send you informational communications related to FM, such as announcements or other information. You may also receive information from us that is specifically about your use of FM or about your account with us, including information about security breaches or other privacy-related matters.

4.1 本公司可能會不定時傳送 FM 相關的資訊性通訊內容，例如公告或其他資訊。您亦可能自本公司收到有關您使用 FM 或您的帳戶的資訊，包括有關安全漏洞或其他隱私權相關事項的資訊。

4.2 By providing any personal information to us, or by using FM in any manner, you have created a commercial relationship with us. As such, you agree that any email sent from us or third-party affiliates, even unsolicited email, shall specifically not be considered SPAM, as that term is legally defined.

4.2 透過提供任何個人資訊給本公司，或以任何方式使用 FM 服務，您與本公司已建立商業關係。因此，您同意本公司或第三方企業所傳送的任何電子郵件，即使是未經請求的電子郵件，亦不應視為垃圾郵件。

5. Protection of Personal Data

5. 個人資料之保護

We protect your personal data by using reasonable security safeguards against loss or theft, unauthorized access, disclosure, copying, use, or modification. Your personal data are contained behind secured networks and are only accessible by a limited number of persons who have special access rights to such systems and are required to keep the personal data confidential. We implement a variety of security measures, such as encryption and pseudonymisation, when users enter, submit, or access their personal data to maintain the safety of your personal data. Please note, however, that no system involving the transmission of information via the Internet, or the electronic storage of data, is completely secure. However, we take the protection and storage of your personal data very seriously and we therefore take all reasonable steps to ensure the ongoing confidentiality, integrity, and availability of your personal data. Nevertheless, we are not liable for any loss, theft, unauthorized access, disclosure, copying, use, or modification of your personal data that occurs outside our reasonable control.

本公司透過使用合理的安全保護措施以保護您的個人資料、防止遺失或遭竊、未授權的存取、揭露、複製、使用或更改。您的個人資料均受到安全網路保護，僅有少數具有此類系統特別進入權限且須對個人資料保密人員始得接觸。當使用者輸入、提交或查閱其個人資料以維護您的個人資料安全時，本公司將會實施各種安全措施，例如加密及去連結化。但請注意，任何涉及透過網際網路傳輸資訊或資料電子儲存的系統均非絕對安全。然而，本公司非常謹慎保護及儲存您的個人資料，因此本公司採取所有合理的措施以確保您的個人資料的持續保密性、完整性及可用性。儘管如此，對於個人資料在本公司合理控制範圍以外所發生的任何遺失、遭竊、未授權的存取、揭露、複製、使用或更改等情況，本公司概不負責。

6. CHOICES AND RIGHTS OF YOUR INFORMATION

6. 資訊自決權

6.1 You may exercise your rights stipulated in Section 6.2 with regard to your personal information collected, processed, and used by FM in which case we may not be able to provide FM Services and this Site to you.

6.1 對於本公司所蒐集、處理及使用您的個人資料，您可行使第 6.2 條規定的權利，在此情況下，本公司可能無法向您提供 FM 服務及本網站。

6.2 You have the right, subject to the applicable laws and Section 6.3 of this Privacy Policy,

- (a) to inquire or request for a review of the personal information FM has collected from you;
- (b) to make duplications of the personal information FM has collected from you;
- (c) to replenish and rectify the personal information FM has collected from you;
- (d) to request FM to discontinue our collection, processing and use of the personal information FM has collected from you; and
- (e) to delete any personal information FM has collected from you,

By yourself or by requesting FM to do so, in which case we may not be able to provide FM Services and this Site to you thereafter. FM cannot, however, delete such personal information that is necessary for compliance with binding legal obligations or if the personal information must be retained according to applicable laws.

6.2 您有權依據相關法律及本隱私權政策第 6.3 條規定，

- (a) 查詢或請求檢閱 FM 自您蒐集的個人資料。
- (b) 請求製作 FM 自您蒐集的個人資料之複製本。
- (c) 請求補充及更正 FM 自您蒐集的個人資訊。
- (d) 請求 FM 停止蒐集、處理及使用 FM 自您蒐集的個人資訊。
- (e) 請求刪除 FM 自您蒐集的任何個人資訊。

您可自行或請求 FM 配合行使上述權利，在此情況下，本公司後續可能提供 FM 服務及本網站給您。然而，FM 不能刪除須遵守具有法律拘束力義務所需的個人資訊，或須依據相關法律規定所保留之個人資訊。

6.3 Upon your inquiry or request for a review and making duplication of the personal information FM has collected from you, FM shall determine whether to agree to such request within fifteen (15) days from the date on which FM receives your request, except:

- (a) when the national security, diplomatic and military secrets, the macro-economic interests or other major national interests may be harmed;
- (b) when the performance of official duties may be interfered with; and
- (c) when the major interests of FM or a third person may be affected.

The fifteen-day period may be extended to a time period of no longer than fifteen (15) days when necessary and you will be notified of the reason of extension in writing (either in electronic or hard-copy form). Please note that FM may charge a fee to those who make an inquiry or request to review, or make duplications of their personal information.

6.3 在您詢問或請求檢閱並製作 FM 自您蒐集的個人資訊之複製本後，除下列情況外，FM 應在收到您的請求之日起十五(15)天內確認是否同意此類請求：

- (a) 可能會損及國家安全、外交及軍事機密、整體經濟利益或其他主要國家利益。
- (b) 妨害公務機關執行法定職務

(c) 妨害 FM 或第三方的重大權益。

如有必要，十五(15)天的期限可再延長最多十五(15)天，而您須以書面（電子或紙本形式）通知延長的理由。請注意，FM 可能會向請求查詢、檢閱或複製其個人資訊複製本的人收取費用。

6.4 Upon your inquiry or request for replenishing and rectifying the personal information FM has collected from you, FM shall determine whether to agree to such request within thirty (30) days from the date on which FM receives your request, except:

- (a) there is a dispute regarding the accuracy of your personal information;
- (b) the processing or use of such personal information is either necessary for the performance of an official duty or fulfillment of a legal obligation of FM or agreed by you in writing (either in electronic or hard-copy form); and
- (c) such dispute has been recorded.

The thirty-day period may be extended to a time period of no longer than thirty (30) days when necessary and you will be notified of the reason of extension in writing (either in electronic or hard-copy form).

6.4 在您詢問或請求補充及更正 FM 自您所蒐集的個人資訊後，除下列情況外，FM 應在收到您的請求之日起三十(30)天內確認是否同意此類請求：

- (a) 對您的個人資訊之正確性具有爭議。
- (b) 處理或使用此類個人資訊對於履行公務或履行 FM 的法律義務而言有其必要，或須取得您的書面同意（電子或紙本形式）。
- (c) 此類爭議業經記錄。三十(30)天的期限可再延長最多三十(30)天，而您須以書面（電子或紙本形式）通知延長的理由。

6.5 You may, as appropriate and in accordance with applicable laws, exercise your rights mentioned above by contacting us through the contact information referred in this Privacy Policy. In some cases, for example, delete or cease the processing or use of your personal information may mean that we may not be able to provide FM Services and this Site to you.

6.5 您可視情況並依據相關法律，經由本隱私權政策所列的聯絡資訊與本公司聯絡，行使您上述權利。在某些情況下，例如，刪除或停止處理或使用您的個人資訊可能表示本公司可能無法向您提供 FM 服務及本網站。

7. COOKIES

7.1 FM may use Cookies to improve and update our services to you. There are two types of cookies, namely, persistent cookies (i.e., cookies that remain valid until their expiration date, unless deleted by the user before that date) and session cookies (i.e., cookies that are stored on a web browser and remain valid until the moment when the browser is closed). We use both persistent cookies and session cookies.

7.1 FM 可能會使用 Cookie 以改善及更新本公司的服務。有兩種類型的 Cookie，亦即持久性 Cookie（亦即在其過期前均保持有效的 Cookie，除非使用者在其到期日前刪除）與工作階段 (session) Cookie（即儲存在網路瀏覽器上並保持有效的
